For each visitor to our Web page, our Web server will automatically recognize the consumer's computer domain name, but not the consumer's e-mail address (when possible).

FCNY collects visitor's domain names, but not their e-mail addresses, the e-mail addresses of those who communicate with FCNY via e-mail, aggregate information concerning pages consumers access or visit, information volunteered by the consumer (such as survey information and site registrations), or visitor's payment information (e.g., credit card number and billing address).

The information we collect is used to improve the content of our Web page, to customize the content and/or layout of our site for each individual visitor, to notify consumers about updates to our Web site, to network with other reputable organizations in order to assist them in contacting consumers for marketing purposes, and to directly contact consumers for FCNY's own marketing purposes.

With respect to cookies: We use cookies to store visitor preferences, to record session information (such as items that consumers add to their shopping cart), and record past site activity, in an effort to provide better service when visitors return.

Persons who provide FCNY with their telephone number(s) through on-line means will only receive telephone contact from us regarding orders placed on-line. FCNY encourages you to provide us with your name and phone number. We will be sure to exclude your name and contact information from lists we share with other organizations.

With respect to Ad Servers: We do not partner with or have special relationships with any ad server companies.

From time to time, we may use customer information for new, unanticipated uses not previously disclosed in our privacy notice. If our information practices change at any time in the future, we will post the policy changes to our Web site. FCNY will only use data collected following the policy change for the new, specified purposes.
